Dear All,

This was my final post to the CLA before Zachari pulled the wire.

"Serious historical abuse allegations and claims made by individuals which have not been through any due process to-date, raise fundamental issues concerning the rules of natural justice and Rights, in our view for ALL including those accused of such serious crimes and those alleging such abuse and those who were abused in the past care system.

Read it, it is simply, explain to me and others what is wrong about all individuals who claim to having been abused going through a proper verifiable and accountable process that scrutinises all accounts and that upholds the Rights of all including those abused and accused.

FBGA and I make no apology for such a statement. It is in others interests such as FACT to undermine and discredit the historical abuse victims and I also support some of the issues that FACT raise as they are fundamental to indivisible justice for ALL. We will not be tainted nor tarnished by others and recent events concerning individuals claiming publicly to be the Chair of the JCLA when it is dishonest and deception, are a prime example of this.

As a group of True Victim Survivors, who have been through the Courts whereby our claims of abuse were upheld. We believe that any Forum set-up in Scotland in the future or envisaged, will have to take into consideration, these issues and other such issues to ensure the rules of natural justice prevail for ALL including those accused and those abused and individuals making such historical abuse allegations."(Email 20th October 2009).

Again my response is the same as above. Others clearly do not understand the historical abuse issues or are trying to facilitate and impose a process which is fundamentally flawed on the Historical abuse survivors where the Quarriers Homes, Historical abuse True Victim Survivors end up tainted and tarnished by others including those who are making false allegations and embellishing such abuse and colluding.

"Is this advisory group fully inclusive of a broad spectrum of representation of the True Victims and Survivors abused in-care and those alleging they were abused in care in Scotland?" (Email, 2nd November 2009).

Clearly this group was selective nor open to public scrutiny nor was there a proper vetting and selection process undertaken. Some may try to misrepresent us and our issues as they have done for years but those days are over and we will not waver in our conviction for true Justice for ALL. The fact that one of the advisors were directly connected to a group of former care leavers (Quarriers Homes former Boys and Girls Association) who were involved in a campaign and intimidation against the Victims of Quarriers, which had to be reported back to Greenock Police, says it all. Perhaps the CLA are not interested in supporting the Historical abuse Victim-survivors and upholding our rights but neverthe less, FBGA and I will defend our honest and integrity regardless as we have done for the past 8 years. We will not be demeaned nor undermined by comments on the CLA website.
